All clubs / individuals proposing to hold Obedience Shows, Agility Shows, Heelwork to Music, Flyball or Rally Competitions under IADSA rules should complete this form and return it by email to the IADSA Secretary at least 90 days prior to the proposed show / competition date. Once received and reviewed the licence will be granted '*in principle*' and the date held.

The full and detailed Show / Competition Schedule must be submitted to IADSA at least 35 days prior to the show date. Upon receipt of the same, the full licence will be granted. Before completing this form, please read the following important notes

- Care should be taken when completing this form, as it will be used to ensure accurate insurance cover is provided, where it is required.
- Licences which are granted '*in principle*' to a Club / Society / Individual by IADSA are considered to be secured dates within the diary.
- The prompt return of this form will greatly assist the compilation of the years' show diary. It will also help clubs / societies to arrange alternative dates to ones already secured for the year where necessary, thus helping to avoid similar shows / competitions running on the same dates.
- A Show, for which a licence had been granted may not be abandoned or postponed, without the permission of IADSA. The licence fee may not be refundable.
- IADSA wish to ensure that all clubs / individuals please read thoroughly the [Competition Rules](#) that govern an IADSA licence
